

**JOPLIN CITY COUNCIL
JULY 2, 2018 MEETING MINUTES**

CALL TO ORDER

The regular meeting for the Joplin City Council was called to order at 6:00 p.m. by Mayor Gary Shaw.

INVOCATION read by Assistant City Clerk Roschelle Forsythe.

PLEDGE OF ALLEGIANCE to the United States of America was led by Mr. West.

ROLL CALL – Answering Roll Call were Taylor Brown, Melodee Colbert-Kean, Doug Lawson, Diane Reid Adams, Gary Shaw; Ryan Stanley, Phil Stinnett, and Jim West. Also in attendance were City Manager Sam Anselm and City Attorney Peter Edwards.

PRESENTATIONS

Van Johnson, Alderman in Savannah, GA, is affiliated with the National League of Cities discussed developing a youth council.

FINALIZATION OF CONSENT AGENDA- There being no further business to come before the Council, the Consent Agenda was finalized.

REPORTS AND COMMUNICATIONS

Pay Plan Update presented by City Manager, Sam Anselm:

The City Manager discussed history of pay increases and past pay plans and the impact it has on employees. He proposed adopting a step plan with 2% increases in between steps, not an across the board raise. This plan would be effective immediately. The impact would recognize all employees in their positions and would demonstrate the city's commitment to its employees, this would be step 1. Step 2 would be ongoing review of pay ranges from other cities. Step 3 would be to address those employees that are topped out in their positions and redesign employee evaluations.

Motion by Mr. Stanley, second by Mr. West to move forward with step 1 as proposed and move on to step 2 after further research has been done. Voting in favor were Council Members: Brown, Colbert-Kean, Lawson, Monteleone, Reid Adams, Shaw, Stanley, Stinnett, and West, 9. Nays: 0.
