

LICENSE AGREEMENT

THIS AGREEMENT is made and entered into this _____ day of _____, 2019, by and between the CITY OF JOPLIN, MISSOURI, a Missouri municipal corporation, hereinafter referred to as "Licensor", and AREA AGENCY ON AGING, REGION X, a Missouri non-profit corporation, hereinafter referred to as "Licensee."

W I T N E S S E T H :

For and in consideration of the mutual promises, covenants, agreements, and understandings herein made and contained, Licensor hereby licenses to Licensee, and Licensee licenses from Licensor, the after-mentioned land and improvements located thereon, to use for the following purposes and subject to the following covenants and conditions, to-wit:

1. Demise. Licensor licenses to Licensee and Licensee licenses from Licensor, the land and improvements commonly known as 2616 S. Picher Ave., Joplin, Missouri 64804 (hereinafter referred to as the "premises").

2. Term. The original term of this License shall commence on September 1, 2019 ("Effective Date") conditioned on a signed Agreement being delivered to Licensor no later than August 31, 2019. The term of this Agreement shall be from September 1, 2019 to August 31, 2022. After August 31, 2022, this Agreement shall automatically renew for successive three (3) year periods under the same terms and conditions, unless terminated pursuant to the terms of this Agreement.

3. Termination. This Agreement shall govern all transactions between the parties until terminated. It is agreed that Licensor shall have the right to terminate this Agreement at any time, without cause, on one hundred eighty (180) days' written notice by certified mail, or by personal delivery, to Licensee. In the event of termination by Licensor, Licensee shall remove all of its equipment, materials, and other property by the end of the one hundred eighty (180) day period. However, any improvements made shall become and remain Licensor's property without compensation of any kind paid to Licensee. Additionally, Licensee shall have the right to terminate this License on sixty (60) days' written notice by certified mail, or by personal delivery, to Licensor, if at any time its funding sources for its services become delayed, reduced, withdrawn, terminated, or are nonexistent; or, if for any reason, Licensee is no longer able to provide the services described in paragraph 7 herein. In the event of termination by Licensee, Licensee shall remove all of its equipment, materials and other property by the end of the sixty (60) day period. However, any improvements made shall become and remain Licensor's property without compensation of any kind paid to Licensee.

4. Rent. Intentionally omitted.

5. Deposit. Intentionally omitted.

6. Use of Premises by Licensee. Licensee is a Missouri non-profit corporation and the Licensed premises shall be used solely for the purposes described herein, unless written

permission is given by an authorized representative of the City. Licensee shall use the Licensed premise solely for the purposes of providing nutrition, support, and recreational services for senior citizens. Any other use of the premises is prohibited. Licensee shall not perform any acts or carry on any practices that may injure the premises or be a nuisance or menace. Licensee shall obtain such state, county, and local, permits or Licenses as may be required.

7. Personal Property, Furniture, and Equipment. As a part of and under the terms of this Agreement, Licensor also agrees to license certain personal property, furniture, and equipment to Licensee, as fully described and set forth on Exhibit A (hereinafter “personal property”). Licensee agrees that the personal property is owned by the City of Joplin and was purchased by Licensor with funds made available through a United States Department of Housing and Urban Development, Community Development Block Grant Disaster Recovery (“CDBG-DR”) grant dated April 16, 2012, under grant number B-12-MT-29-0001. Licensee further agrees that the personal property will be licensed to Licensee subject and subordinate to a Security Agreement and UCC-1 financing statement filed with the Missouri Secretary of State’s Office, between Licensee and the Licensor as the secured party. Licensee shall have no obligation to replace items on Exhibit A once they have served their useful life.

8. Licensee’s Responsibilities. This Agreement is conditioned upon Licensee’s assurances that the premises shall be maintained and operated solely by Licensee and no other person, corporation, association or legal entity whatsoever. All of Licensee’s personnel and volunteers shall be the sole responsibility of Licensee. Licensee shall leave the premises in the same condition as it was prior to the start of this Agreement, excepting the improvements as described herein. Licensee shall be responsible for securing the property. Licensor is not responsible for any loss suffered by Licensee. Licensee further agrees as follows:

- a. To provide nutrition services to senior citizens in accordance with Federal Program Guidelines.
- b. To provide recreational and support services to senior citizens.
- c. To employ, train, and supervise such employees as are necessary for the operation of nutrition, recreational, and support services to senior citizens in accordance with current Administration on Aging requirements.
- d. To pay for or provide for maintenance and janitorial services for the inside of the premises, including all inside equipment and furnishings.
- e. To at all times comply with the Senior Center Use Policy, attached hereto and incorporated by reference as Exhibit B.

9. Licensor’s Responsibilities. Licensor shall maintain the property in a habitable condition. Licensor shall maintain the electric, plumbing, and HVAC systems in good working order. Licensor shall maintain the parking lot and walkway areas including the removal of snow. Licensor shall mow the premises.

10. Utilities. Licensor shall pay for the following utilities: electric, gas, water, and sewer. Licensee shall pay for the following utilities: trash.

11. Telecommunications. Licensee shall be solely responsible for any telephone, fax, cable, and internet service. However, Licensee shall not be responsible for any public internet provided by Licensor.

12. Fixtures and Alterations. Licensor and Licensee hereby agree that the premises are Licensed in an "AS IS" condition. As described in Section 3, *supra*, any improvements made shall become and remain Licensor's property without any compensation of any kind paid to Licensee.

13. Maintenance of Licensed Premises. Licensee shall at all times maintain the Licensed premises in good condition and repair and keep the premises in a neat and orderly condition.

14. Insurance. Licensee shall, during the entire term of this License, keep in full force and effect policies of public liability and property damage insurance with respect to the Licensed premises and the business operated by Licensor in the Licensed premises, in which the limits of public liability shall not be less than the sovereign immunity limit established by Section 536.610, RSMo. The policy shall name Licensor, any person, firms or corporations designated by Licensor, and Licensee as additional insureds. The insurance shall be in an insurance company acceptable to Licensor and a copy of the policy or a Certificate of Insurance shall be delivered to Licensor upon execution of this License Agreement.

15. Indemnification of Licensor. Licensee hereby assumes all risk of, and responsibility for, and agrees to indemnify and save harmless Licensor, from and against any and all claims, demands, suits, actions, recoveries, judgments and costs and expenses therewith made, brought or obtained on account of the loss of life or property or injury or damage to the person or property of any person or persons whomsoever, whether such person or persons be Licensor, their agents or employees, or Licensee, its agents or employees, or any third person in any way connected with the parties hereto, which loss of life or property, or injury or damage to persons or property, shall be due to, or arise out of, result from, or be in any way connected with, this License or any work done thereunder or business carried on by Licensee during the term of the License and on the Licensed premises.

16. Damage or Destruction of Licensed Premises. In the event that the Licensed premises are destroyed or damaged so as to be unfit for use by fire, storm, explosion, earthquake or other casualty, so as not to be capable of being economically rebuilt or restored by the date of this License, then this License shall be automatically terminated.

17. Default of the Licensee. In the event of any failure by Licensee to perform any of the terms, conditions or covenants of this License to be observed or performed by Licensee for more than five (5) days after written notice of such default shall have been given to Licensee, then Licensor, besides other rights and remedies it may have, shall have the immediate right of re-entry and may remove all persons and property from the Licensed premises without service of notice or resort to legal process and without being deemed guilty of trespass or becoming liable for any loss or damage which may be occasioned thereby. Should Licensor at any time terminate this License for any breach in addition to any other remedies it may have, it may recover from Licensee all

damages it may incur by reason of such breach. Licensee further agrees to indemnify Licensor for any and all costs and expenses, including attorney fees, incurred by Licensor in any lawsuit against Licensee to enforce the terms of this License.

18. Right of Entry. Licensor or Licensor's agents shall have the right to enter the Licensed premises at all reasonable times to examine the same and to make such repairs, alterations, improvements or additions as the Licensor may deem desirable, and Licensor shall have the right to enter the premises to conduct routine health inspections and other inspections as deemed necessary by Licensor.

19. Notices. All notices, requests, and other communications hereunder shall be in writing and shall be deemed to be duly given if delivered or deposited in the U.S. Mail, First Class Postage prepaid, Certified, Return Receipt Requested, (except for rent payments) to the Licensor as follows:

Each party may, from time-to-time, designate a different address by notice given in conformity with this paragraph. The date of mailing as indicated on the U.S. Postal Return Receipt shall be the commencement date for calculating any time periods associated with the giving of notice hereunder.

20. Amendments. It is acknowledged that the covenants and obligations herein contained are the full and complete terms of this License Agreement, and no alteration, amendments or changes to such terms shall be binding unless first reduced to writing and executed with the same formality as this Agreement. This provision shall not apply to changes of address for forwarding of notice or rental payments.

21. Assignment and Subletting. Licensee will not assign this License in whole or in part without obtaining the prior written consent of the Licensor. Any assignment without Licensor's consent in writing shall be void.

22. Headings. The headings hereof are intended as guides only and shall not be construed as having any legal effect.

23. Compliance with Applicable Laws. Licensee shall comply with all applicable laws, ordinances, rules and regulations.

24. Entire Agreement. This instrument embodies the whole agreement of the parties. There are no promises, terms, conditions or obligations other than those contained herein and this Agreement shall supersede all previous communications, representations or agreements, either verbal or written, between the parties.

25. Governing Law. This Agreement has been made, and its validity, performance and effect shall be determined, in accordance with the laws of the State of Missouri and venue for litigation between the parties shall be solely and exclusively in Jasper County, Missouri, or the United States District Court for the Western District of Missouri.

26. Heirs, Successors and Assigns. Each and every obligation contained in this License Agreement shall be jointly and severally binding upon the respective parties, their heirs, legal representatives, successors and assigns.

27. No Implied Waivers. The right of any party under any provision of this Agreement shall not be affected by its prior failure to require the performance by the other party under such provision or any other provision of this Agreement, nor shall the waiver by any party of a breach of any provision hereof constitute a waiver of any succeeding breach of the same or any other provision or constitute a waiver of the provision itself. A waiver of any right or obligation hereunder must be in writing and signed by the parties to this Agreement.

28. Contingent on Approval. This Agreement is contingent on approval from the Joplin City Council and Area Agency on Aging, Region X Board of Directors.
