SUMMARY

This Grant Offer for Airport Improvement Program (AIP) Project No. 3-29-0037-045-2021 at Joplin Regional Airport not to exceed the amount of Five Million Nine Hundred Fifty-Four Thousand One Hundred Sixty-Nine and no/100 dollars (\$5,954,169.00) is provided in accordance with the FAA approved project consisting of the Phase 3 - Reconstruct North 3,500 Feet Of Runway 18/36 (3,500' x 100'), And Replace Adjacent Runway Lights.

The Federal Aviation Administration, for and on behalf of the United States, hereby offers and agrees to pay One Hundred (100%) percent of the allowable costs incurred accomplishing the Project as the United States share of the Project.

BACKGROUND

The FAA required this project to be prepared as a multi-phased project in order to match the funding cycles within the legislative appropriations. The FAA issued a Go Letter on October 2, 2018 for the Phase 1 Engineering Design for the Reconstruction of Runway 18-36. On August 5, 2020 FAA issued a Go letter to begin the construction project under Phase 2. This Grant offer is to cover the final Phase 3 of the project. Please reference the attached project breakdown sheet for a description of the project Phases.

FUNDING SOURCE

Federal Aviation Administration Grant

RECOMMENDATION

Staff recommends adoption of this Council Bill on an Emergency basis, being an Ordinance dealing with a general appropriation, within the meaning of Section 2.12(4) of the Home Rule Charter of the City of Joplin, Missouri, and, as such, this Ordinance shall become effective immediately upon its passage. Specifically, this council bill needs to be approved in order to meet FAA Guidelines for grant acceptance.
