

**COUNCIL BILL NO. 2022-134**

**ORDINANCE NO**

AN ORDINANCE authorizing the City of Joplin to enter into an agreement with Performance Boiler and Mechanical LLC., for a purchase order in the amount of Two Hundred Thirty-Four Thousand Three Hundred Forty-Four and 47/100 Dollars (\$234,344.47) for construction services associated with replacing a boiler at the Shoal Creek Wastewater Treatment Facility on behalf of the City of Joplin and authorizing the City Manager or his designee to execute the same by and on behalf of the City of Joplin; and containing an emergency clause.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF JOPLIN, as follows:

Section 1. That the agreement by and between the City of Joplin and Performance Boiler and Mechanical, LLC., in the amount of Two Hundred Thirty-Four Thousand Three Hundred Forty-Four and 47/100 Dollars (\$234,344.47) for construction services associated with the Shoal Creek Wastewater Treatment Facility Boiler on behalf of the City of Joplin; true and accurate copy of said agreement being attached hereto and incorporated herein, be, and the same is hereby approved.

Section 2. That the City Manager of the City of Joplin, Missouri, is hereby authorized and directed to execute said agreement, or agreement in substantially similar form, by and on behalf of the City of Joplin.

Section 3. That upon final approval and acceptance of Performance Boiler and Mechanical LLC., work under said contract, in substantial conformance with the attached work authorization, in writing to the Director of Public Works and his certification to the effect to the Director of Finance, Performance Boiler and Mechanical LLC., shall be paid from the Wastewater Fund.

Section 4. That the City of Joplin hereby declares that this Ordinance, approving a construction agreement on an Emergency basis due to Sanitary Sewer and structural rehabilitation, being an ordinance relating to a public improvement, it is an emergency within the meaning of Section 2.12(6) of the HOME RULE CHARTER of the City of Joplin, Missouri and the Council hereby declares that this ordinance shall be in full force and effect from and after its passage.
