CALL TO ORDER

The June 20, 2022, regular meeting of the Joplin City Council was called to order at 6:00 p.m. by Mayor Doug Lawson.

News from the Public Information Office

The public is invited to come out on Wednesday, June 22 and join Joplin firefighters, City officials and other community members during a “wet down” ceremony for the new ladder truck being put into service at Joplin Fire Station #5. The event will be held at 3 p.m. on Wednesday, June 22 at Joplin Fire Station #5, 3223 S. Texas Avenue. (Parking is available on the southwest side of the Food 4 Less parking lot.)

After the wet down portion of the event, participants can join firefighters to “push” the truck into the station to be ready for the next call. This tradition of wetting down a fire truck as it begins service is reminiscent of the late 1800s when fire departments used horses to pull a fire apparatus to fires. After fighting the fire, the crews would wash and ready the horses and the apparatus in preparation for the next call. Crews push the apparatus into the station’s bay because the horse-drawn equipment could not be easily

backed into the building. To move the equipment into the station, firefighters and community members gathered as a group to push the heavy equipment into the fire bay.

As July 4th Independence Day approaches, citizens need to keep safety in mind as they handle fireworks to avoid any problems. We remind everyone to adhere to all regulations involving the sale and discharge of fireworks in Joplin, and also ask citizens to be a good neighbor and remove any trash or debris from the fireworks they discharge.

Fireworks may be sold within the City of Joplin from July 1 to July 4th. They may be discharged from 12 noon to 11 p.m. on July 1st through July 4th.

Residents cleaning up their shoot site should ensure fireworks are cooled before they are disposed of. Remaining fireworks barrels can be sprayed with water or dunked in a bucket before disposing them. We appreciate everyone's help in keeping our community clean during this festive holiday.

Joplin Parks & Recreation and Missouri Southern State University have once again joined together for Joplin's Independence Day celebration. Event will be held at Fred G. Hughes Stadium at Missouri Southern State University on Monday, July 4.

Food vendors will open at 5:30 P.M. in the stadium parking lot, and the stadium opens at 7 p.m. Live music begins at 7:30 as the band Mixed Tapes entertains the crowd. Fireworks start at begin at 9:45 p.m. Guests can sit in the stadium or bring lawn chairs and blankets for lounging in the grassy area on the west side of the field. This is a family fun event and everyone is welcome!

A reminder – the online public meeting for Missouri Department of Transportation regarding improvements along Missouri Route 66, also known as 7th Street, is open through Sunday, June 26. Mr. Cortez introduced Council Bill No. 2022-134 - AN ORDINANCE authorizing the City of Joplin to enter into an agreement with Performance Boiler and Mechanical LLC., for a purchase order in the amount of Two Hundred Thirty-Four Thousand Three Hundred Forty-Four and 47/100 Dollars (\$234,344.47) for construction services associated with replacing a boiler at the Shoal Creek Wastewater Treatment Facility on behalf of the City of Joplin and authorizing the City Manager or his designee to execute the same by and on behalf of the City of Joplin; and containing an emergency clause. Motion by Mr. Cortez, Voting in favor were Council Members: Copple, Cortez, DeTar, Farnham, Lawson, Shaw, Spencer and Stinnett, 8. Nays: 0. Absent: Williams, 1. The Council Bill was declared adopted and entitled **Ordinance No. 2022-104.**

Mr. Shaw introduced Council Bill No. 2022-521 - AN ORDINANCE approving a Contract by and between the City of Joplin and Guidehouse Inc. to provide ARPA-Infrastructure related assistance; authorizing the City Manager to execute said Contract by and on behalf of the City of Joplin; and, amending the Annual Budget of the City of Joplin for the Fiscal Year 2021-2022 as adopted by Ordinance 2021-149 on October 18, 2021 and containing an emergency clause.

Mr. Cortez introduced Council Bill No. 2022-125- AN ORDINANCE authorizing the City of Joplin to enter into an agreement with C & L Grease and Wastewater Services for Sludge Hauling On-Call Services not to exceed the amount of One Hundred Fifty Thousand and 00/100 Dollars (\$150,000.00) for Sludge Application and Hauling, authorizing the City Manager or his designee to execute the same by and on behalf of the City of Joplin. Motion by Mr. Cortez, second by Dr. Farnham that Council Bill No. 2022-125 be passed on first reading and advance to second and third. Voting in favor were Council Members: Copple, Cortez, DeTar, Farnham, Lawson, Shaw, Spencer and Stinnett, 8. Nays: 0. Absent: Williams, 1. The Bill was read as Council Bill No. 2022-125.

COUNCIL BILL NO. 2022-133

Mr. Copple introduced Council Bill No. 2022-133 - AN ORDINANCE authorizing the City of Joplin, Missouri, to enter into a Marketing Agreement with Utility Service Partners Private Label, Inc., a Delaware Corporation, for the purpose of promoting a service line warranty program; and authorizing the City Manager or his designee to execute the same by and on behalf of the City of Joplin. Motion by Mr. Copple, second by Mr. DeTar that Council Bill No. 2022-133 be passed on first reading and advance to second and third. Voting in favor were Council Members: Copple, Cortez, DeTar, Farnham, Lawson, Shaw, Spencer and Stinnett, 8. Nays: 0. Absent: Williams, 1. The Bill was read as Council Bill No. 2022-133.

Motion by Mr. Copple, second by Ms. Spencer that Council Bill No. 2022-522 be passed on first reading and advance to second and third. Voting in favor were Council Members: Copple, Cortez, DeTar, Farnham, Lawson, Shaw, Spencer and Stinnett, 8. Nays: 0. Absent: Williams, 1. The Bill was read as Council Bill No. 2022-522.
