

**JOPLIN CITY COUNCIL
JANUARY 4, 2021
MEETING MINUTES**

CALL TO ORDER

The January 4, 2021 regular meeting of the Joplin City Council was called to order at 6:00 p.m. by Mayor Ryan Stanley.

INVOCATION was read by City Clerk Barbara Gollhofer.

PLEDGE OF ALLEGIANCE to the United States of America was led by Ms. Williams.

ROLL CALL

Answering Roll Call were Council Members: Charles Copple, Keenan Cortez, Doug Lawson, Anthony Monteleone, Diane Reid Adams, Gary Shaw, Mayor Ryan Stanley, Phil Stinnett and Christina Williams. Also, in attendance were City Manager Nick Edwards and City Attorney Peter Edwards.

FINALIZATION OF CONSENT AGENDA

There being no further business to come before the Council, the Consent Agenda was finalized.

REPORTS AND COMMUNICATIONS

Health Department Update

Health Director Ryan Talken gave an update on Covid cases. As of December 26, 2020, there was an average of 41 cases per day; 96 Joplin deaths; 90 combined hospitalizations (Joplin residents). The Joplin Health Department has not received any vaccines at this time. The available vaccines (offered through health care facilities) is focused on group 1A: residents and employees at long term care facilities, and front-line health care workers. The next phase of vaccines will be for group 1B: high risk people ages 18-64, First Responders and essential workers. Director Talken stated the demand for vaccines exceeds the availability and he does not know when the next shipment of vaccines will arrive in Joplin. Mayor Stanley asked Director Talken if he had any recommendations regarding the Recovery Plan. Director Talken advised to stay the course.

News from Public Information Officer Lynn Onstot

The City will open the tree limb site starting Thursday, January 7 through Saturday, January 9 from 8:30 a.m. to 2 p.m. on those days. The site is located at 1702 North Schifferdecker Avenue, about six tenths of a mile north of Belle Center Road on the west side of Schifferdecker Avenue. This free drop off service is for Joplin residents only. Professional contractors will not be allowed to dump. Joplin residents have another option through their residential trash service with Republic Services. Republic allows yard waste removal on their regular trash pick-up day. Limbs must be cut to a maximum of four (4) feet and tied in bundles no heavier than 50 pounds. They ask that the diameter of each tree limb be no larger than four (4) inches.

Residential Leaf Pick-up is continuing. The City's two crews are making progress as they canvas all residential streets. The crew from Parks & Rec are finishing the P3 area which includes residences from 32nd Street to 20th Street from Range Line Road to west boundaries, and properties south of 32nd Street west of McClelland Boulevard. The P4 area is just north of that and will start soon.

The Streets Crew has moved to S3 to pick leaves up in neighborhoods between Joplin's northern boundary (including residents N of Fountain Road & W of St. Louis Ave.) to 15th Street between St. Louis Avenue and Main Street. Crews are working from the north end and moving toward 15th Street within the east/west boundaries stated. Crews are delayed during wet conditions. The Parks & Recreation Department is hiring cashiers, recreation instructors, lifeguards, and seasonal laborer positions at the Athletic Complex, the 3 aquatic centers, Schifferdecker Golf Course, and the parks. It's a great summer job for those in high school and college! Applicants must be 16 years or older by start date, 18 years or older for laborer positions.
