MEETING MINUTES

CALL TO ORDER

The March 15, 2021 regular meeting of the Joplin City Council was called to order at 6:00 p.m. by Mayor Ryan Stanley.

INVOCATION was read by City Clerk Barbara Gollhofer.

PLEDGE OF ALLEGIANCE to the United States of America was led by Mr. Cortez

FINALIZATION OF CONSENT AGENDA

There being no further business to come before the Council, the Consent Agenda was finalized.

REPORTS AND COMMUNICATIONS

Health Department Update:

Health Director Ryan Talken presented the latest COVID and vaccine statistics: cases and hospitalizations continue to decrease. Vaccine supplies continue to increase, and more independent vaccinators are administering vaccines. Phase 1 Tier 3 of the vaccination process was activated today, focusing on vaccinating what the state classifies as its "critical infrastructure". It includes teachers, childcare providers, grocery store employees and those who work in the food and agriculture industries. Mr. Talken made no recommendations or changes to the Recovery Plan.

Joplin Parks and Recreation has programs, leagues, and events for all ages. From age 4 to adults, you can enjoy softball, baseball, soccer, t-ball, and even a Flashlight Easter Egg Hunt. Parks and Rec is also in the process of recruiting more than 150 seasonal workers to their Department, including laborers to help at the golf course, cemeteries, and parks maintenance divisions and staff to work at our pools this summer.

The City's Tree Limb Drop Off Service will be open Saturday, March 20 from 8:30 a.m. to 2 p.m. This drop off site will be open the third Saturday of the month through October, unless there is a weather event that warrants another date being set. The drop-off site is located at 1702 North Schifferdecker Avenue, six tenths of a mile north of Belle Center Road on the west side of Schifferdecker. This free drop-off service is for Joplin residents only and has no load limits.

CITIZEN REQUESTS AND PETITIONS

Joseph Johnson requested to speak on emergency preparedness for our homeless population. Mr. Johnson spoke on behalf of the Homeless Emergency Action Team (HEAT) and asked the City to partner with them to come up with a preparedness plan to provide food, safety, and shelter to the homeless community during times of crisis. The Council consented to allow city staff to work with Mr. Johnson and his group on a preparedness plan.

This agreement additionally provides for the hosting of the website, following launch through FY2024. ORDINANCES – SECOND AND THIRD READING**UNFINISHED BUSINESS****NEW BUSINESS**Discussion of HB920

Mr. Monteleone opened the discussion on HB920 and stated the bill would eliminate the April Municipal Election. There are already limited options throughout the year to hold elections, and decreasing these options negatively impacts the ability for voters to be engaged on local issues. The April ballot includes important local races for city council and school board representatives and moving the municipal election to November will make it more costly to educate voters about local ballot measures. After discussion, Mr. Monteleone made a motion to have the city attorney draft a resolution to declare opposition to HB 920, Elimination of the April Municipal Election, on behalf of the Joplin City Council. Mr. Lawson seconded the motion. Voting in favor were Council Members: Copple, Cortez, Lawson, Monteleone, Reid Adams, Shaw, Stanley, Stinnett, and Williams, 9. Nays: 0.

OTHER BUSINESS

Mr. Copple asked for an update on the seasonal pay issue. City Manager Nick Edwards replied that the Finance Dept. will provide an update at the next informal city council meeting.

Mr. Copple questioned the status of the Action Plan dealing with recruitment and retention in the police department that was discussed at the March 8 work session. After discussion of the status, City Staff was directed to implement the action steps to update a recruiting plan and conduct a study for implementation of a Recruitment Incentive Program, as presented by Chief Rowland.

There being no further business, the meeting adjourned at 8:07 p.m.
