

**JOPLIN CITY COUNCIL
OCTOBER 4, 2021
MEETING MINUTES**

CALL TO ORDER

The October 4, 2021 regular meeting of the Joplin City Council was called to order at 6:00 p.m. by Mayor Ryan Stanley.

INVOCATION was read by City Clerk Barbara Gollhofer.

PLEDGE OF ALLEGIANCE TO THE UNITED STATES OF AMERICA was led by Mr. Shaw.

ROLL CALL

Answering Roll Call were Council Members: Charles Copple, Keenan Cortez, Doug Lawson, Anthony Monteleone, Gary Shaw, Diane Reid Adams Mayor Ryan Stanley, Phil Stinnett, and Christina Williams. Also, in attendance were City Manager Nick Edwards and City Attorney Peter Edwards.

PRESENTATIONS

Mayor Stanley presented a resolution to Dan Pekarek to recognize Dan upon his retirement after 35 years of service to the City of Joplin. Dan served as Public Health Director for 23 years and led significant public health projects to assist and protect the wellbeing of citizens. He served as Interim City Manager from March 2019 through March 2020 and was named Assistant City Manager in June 2020. During his time with the City, Dan worked closely with the Environmental Protection Agency and helped establish the Jasper and Newton Counties Community Health Collaborative and Emergency Healthcare Coalition. He received the prestigious 2021 W. Scott Johnson Award in recognition of his distinguished service in the field of public health in Missouri and in commemoration of his skills, integrity, devotion to duty and constructive leadership. Dan served on numerous local and state committees and his contributions to the City and community are greatly appreciated. Mayor Stanley noted that Dan Pekarek was awarded a Key to the City during a recognition event at Mercy Park on October 1. The award is the highest honor bestowed by the City Council to acknowledge the contributions of an individual furthering the ideals of the city and to recognize outstanding achievements for longevity work to the City of Joplin.

There being no further business to come the Council, the Consent Agenda was finalized.

News from Public Information Officer, Lynn Onstot

Joplin High School's Parade is Wednesday, October 6, at 6:30 p.m. It will be on Main Street and run from 3rd Street to 7th street. Joplin Eagles will host Carthage Tigers for their Homecoming Game at 7 p.m. at Junge Stadium on Junge Boulevard. Both teams are 6 and 0.

Beginning Monday October 11, the west entrance to City Hall will be closed during normal business hours. Access to the building will only be available by using the Main Street entrance or the 6th Street entrance. This closure will allow contractors to safely continue the brick restoration along the west corners of City Hall. Access to the utility payment box located on the west side near the alley will be also closed during business hours. The drop box will be accessible during evening and weekend hours. These closures will be in effect for approximately two weeks, with completion set for October 25. We appreciate everyone's understanding during this time.

The First Thursday Art-Walk will take place this Thursday, October 7 from 5:30 to 8:30 p.m. from Fourth to Seventh Streets on Main Street and on Joplin Avenue. At 5 p.m. that day, the National Arts & Humanities Month kickoff will take place in Spiva Park at 4th and Main. The ceremony will include several music, poetry, and an introduction by Linda Teeter of ArtWalk. The Arts community will also receive a Proclamation recognizing this month presented by Mayor Stanley. The City's tree limb and brush drop-off site will be open Friday, October 15 and Saturday, October 16 from 8:30 a.m. to 2 p.m. The drop-off site is located at 1702 North Schifferdecker Avenue, about ½ mile north of Belle Center Road on the west side of Schifferdecker. Drop offs are free of charge for Joplin residents. This will conclude the scheduled limb drop off program for this year. In November crews will be preparing for the City's Leaf Pick Up program. Generally, leaf pick up starts the Monday after Thanksgiving. So please watch for announcements in the near future.

Mr. Lawson introduced Council Bill No. 2021-405 - an ordinance approving an Agreement between the City of Joplin, Missouri, and Missouri Highway and Transportation Commission which will provide FHWA Metropolitan Planning Assistance and FTA Section 5303 assistance, hereafter known as Consolidated Planning Funds, from November 1, 2021, through October 31, 2022, in accordance with the rules of the U.S. Department of Transportation, Federal Transit Administration (FTA) and Federal Highway Administration (FHWA) under 49 U.S.C. Section 5303 and 23 U.S. Code Sections 104(F) and 134 to conduct comprehensive and transportation planning programs, as the City of Joplin has been designated to conduct transportation planning programs for the Joplin Area Transportation Study Organization; authorizing the City Manager or his designee to execute said Agreement for the City.
