JOPLIN CITY COUNCIL OCTOBER 18, 2021 MEETING MINUTES

CALL TO ORDER

The October 18, 2021 regular meeting of the Joplin City Council was called to order at 6:00 p.m. by Mayor Ryan Stanley.

INVOCATION was read by City Clerk Barbara Gollhofer.

PLEDGE OF ALLEGIANCE TO THE UNITED STATES OF AMERICA was led by Mr. Cortez.

ROLL CALL

Answering Roll Call were Council Members: Charles Copple, Keenan Cortez, Doug Lawson, Anthony Monteleone, Gary Shaw, Diane Reid Adams Mayor Ryan Stanley, Phil Stinnett, and Christina Williams. Also, in attendance were City Manager Nick Edwards and City Attorney Peter Edwards.

PRESENTATIONS

Proposition Action: Listening To You

Rob O'Brien, Co-Chair of the Citizens Use Tax Committee for Proposition Action discussed the committee's efforts to educate citizens on the proposed local use tax for the city that will be on the November 2 ballot. After his presentation, he asked the city council to consider forming another citizen committee to oversee the implementation of the action plans as promised if the use tax is approved by the voters.

Olivia Apartments Update

Sawyer Smith with Blue Haven Homes, LLC presented an update of the Olivia apartments and stated the roof is on and now they are working to remove damaged material from previous water damage. There are plenty of fans and generators drying out the basement so that the foundation and floorboards can be saved. The project is still on target for completion in March 2023. Police Department CALEA accreditation award

Joplin Police Chief Sloan Rowland stated the CALEA (Commission on Law Enforcement Agencies) award is the gold standard in public safety. It was created in 1979 as a credentialing authority through the join efforts of law enforcement's major executive associations. The award is given to law enforcement agencies that demonstrate compliance with an established set of professional standards on a voluntary basis, and includes an external, objective evaluation of departmental operations. This is the fifth time the JPD was recognized for this award.

Health Dept. Update

Health Director Ryan Talken stated there was an increase in positive Covid cases since his last report – 50 active cases vs. 29. News from Public Information Officer, Lynn Onstot

The City will host a Public Open House highlighting the City's Active Transportation Assessment this Thursday, October 21 at the Joplin Senior Center, 2717 Picher Avenue. This come and go open house will be held from 5 p.m. to 7 p.m. City staff, along with partners from Olsson, will present data, maps, and recommendations based on the analysis. This is the second public open house for this project and gives citizens a chance to review and provide input on the efforts thus far, along with the preliminary bicycle network.
