

**JOPLIN CITY COUNCIL  
NOVEMBER 4, 2019 MEETING MINUTES**

**CALL TO ORDER**

The regular meeting of the Joplin City Council was called to order at 6:00 p.m. by Mayor Gary Shaw.

**INVOCATION** was read by City Clerk Barbara Gollhofer.

**PLEDGE OF ALLEGIANCE** to the United States of America was led by Mr. Brown.

**PRESENTATIONS**

Terry Wachter, Co-Chair of the Citizen Prop B Task Force presented a short informational video to educate the voters about the proposed ½ cent sales tax increase that will be dedicated to funding the public safety retirement plan to help improve recruitment and retention of Joplin police officers and firefighters. Ms. Wachter thanked all those involved for their efforts to help inform the public on the proposal that will be voted on tomorrow, November 5.

Also speaking on behalf of the proposal was task force member Scott Vorhees, who expressed his thanks to everyone for the collaborative effort on the part of the city, community, and police and fire on the way this issue was handled.

Jeremie Humphrey, president of Joplin Firefighters Local 59, presented a short video that supported the Prop B proposal. He stated Prop B will help with public safety recruitment and retention. He also thanked everyone, especially the citizens who got involved with this issue.

Midwest Fibre Sales will have their mobile shred truck at the Center from 10 a.m. to 2 p.m. for residents to rid themselves of personal papers that are no longer needed without worry of identity theft. This free event is sponsored by the City's Recycling Division, Region M Waste Management District, and the Missouri Department of Natural Resources.

Everyone is invited to Main Street this Saturday, November 9<sup>th</sup> for Joplin's 32<sup>nd</sup> Annual Veterans Day Parade! It starts at 10 a.m., beginning at 15<sup>th</sup> Street and heading north to 3<sup>rd</sup> Street. From there it turns west, and then goes south on Joplin Avenue to Memorial Hall.

Citizens interested in running for a City Council seat in April 2020 may pick up their nominating petitions from the City Clerk starting Tuesday, November 19, 2019. Petitions must be returned to the City Clerk by 5 p.m., Tuesday, January 14, 2020 to be eligible for the April 7, 2020 election.

The Downtown Lighting Celebration in Joplin will be Monday, November 25. Main Street will be closed from 2<sup>nd</sup> to 7<sup>th</sup> Street for people to enjoy a fun evening with friends and family. Festivities begin at 5 p.m., with Parks and Recreation staff hosting crafts for the kids at Spiva Park, while waiting for Santa's arrival at 5:30. At 6, the official lighting of Spiva Park will illuminate the park with holiday scenes and songs! At 6:30 p.m. a holiday-themed movie will be shown on Main Street near City Hall at 6<sup>th</sup> Street. As people walk along Main Street, they'll enjoy more holiday entertainment and festive window decorations. Be sure to vote for your favorites in the contest hosted by the Downtown Joplin Alliance. Ballots can be dropped off at City Hall that evening, while writing letters to Santa and having cocoa and cookies. This holiday evening celebration will end at 8:30 p.m. More details can be found on our website and in the City's newsletter.
