Motion by Mr. Stinnett, second by Mr. McCreary to postpone the remainder of the appointments. Voting in favor were Council Members: Brown, Colbert-Kean, McCreary, Seibert, Shaw, Stanley, West 7. Nays: 1, Stinnett. Absent: 1, Lewis.

Mr. Stinnett said you all know Mr. Glaze has made application to the JIDA Board. I have asked the Council to push for a vote of waiver for city code 2-50. Mayor asked the City Attorney to define the City Code Section 2-50 (f)(3). No Council Member shall for a period of one year after serving the City appear before any board, commission, committee or agency of the city in relation to any, proceeding or application in which he personally participated during the period of his service or which was under his active consideration. A councilmember shall not be employed by the city, or any of its departments, boards, or agencies, for a period of one year after leaving the position of councilmember. After comments from members of council Mr. Stinnett made a motion with a Second by Mr. Stanley to look into potential language for a waiver dealing with this portion of the city code dealing with the one-year absence of a city council member prior to being appointed to a board, commission, or committee.

Ms. Colbert-Kean asked City Attorney if it were dealing with the Charter language and the City Attorney replied it was the City Code 2-50 section.

Mayor said the City Attorney would look into a what a waiver would look like and present to Council. Voting in favor were Council Members: Brown, Colbert-Kean, McCreary, Seibert, Shaw, Stanley, Stinnett, West 8. Nays: 0. Absent: 1, Lewis.

Motion by Mr. Stanley, second by Ms. Colbert-Kean that applications for boards and commissions must be received in the office of the City Clerk office by noon on Thursday prior to the Council meeting day in order to be included in the packet. Voting in favor were Council Members: Brown, Colbert-Kean, McCreary, Seibert, Shaw, Stanley, Stinnett, West 8. Nays: 0. Absent: 1, Lewis.
