

**JOPLIN CITY COUNCIL
NOVEMBER 19, 2018 MEETING MINUTES**

CALL TO ORDER

The regular meeting for the Joplin City Council was called to order at 6:00 p.m. by Mayor Gary Shaw.

INVOCATION read by City Clerk Barbara Gollhofer.

PLEDGE OF ALLEGIANCE to the United States of America was led by Mr. Monteleone.

ROLL CALL – Answering Roll Call were Council Members: Taylor Brown, Melodee Colbert-Kean, Doug Lawson, Anthony Monteleone, Diane Reid Adams, Gary Shaw, Ryan Stanley, Phil Stinnett and Jim West. Also, in attendance were City Manager Sam Anselm and City Attorney Peter Edwards.

PRESENTATIONS

Mayor Shaw presented a proclamation to proclaim Tuesday, November 27, 2018 as Giving Tuesday to Stephanie Brady, Executive Director of the Community Clinic of Southwest Missouri. Ms. Brady expressed her appreciation for the community and thanked the City for their assistance.

Janus Lazarus, president of the Joplin Table Tennis Club, and Jared Wicklund, vice president of Joplin Table Tennis Club presented a trophy to the Joplin Police Department for winning the 2018 Table Tennis Championship City Challenge against the City Council. Representing the City Council were Ryan Stanley, Taylor Brown and Anthony Monteleone. Representing the Police Department were Shelby Howard, Aaron Gooch, Bryan Leper and Jason Barchak.

Doug Hunt made a request on behalf of a volunteer group, that the City Council approve a resolution to designate land at the northeast corner of 20th St. and Murphy Blvd. to display a permanent sculpture of the Spirit Tree, which stood on the site of Dillon's grocery store after the 2011 tornado until its demise earlier this year. The Spirit Tree represented recovery and resiliency after the storm. The group will not seek any financial support from the city. Community members and businesses will fund this project. The hope is that the Spirit Tree will inspire generations to come. After the presentation, Mr. Stanley made the motion to proceed with the resolution, seconded by Mr. West. Voting in favor were Council Members: Brown, Colbert-Kean, Monteleone, Reid Adams, Shaw, Stanley, Stinnett and West, 8. Nays: 0. Abstention: Lawson, 1.

Mrs. Reid Adams introduced Council No. 2018-158 - an ordinance approving the contract between the City of Joplin, Missouri and Transystems Corporation in the not to exceed amount of One Hundred Forty-One Thousand Four Hundred One dollars and No/100 (\$141,401.00) for engineering services associated with Transit System Service Evaluation and Short, Medium, and Long-Term Transit Planning Assistance for the Sunshine Lamp Trolley and MAPS Transit systems; and amending the Annual Budget of the City of Joplin for the Fiscal Year 2018-2019 as adopted by Ordinance 2018-145 on October 15, 2018; and, containing an emergency clause. Motion by Mrs. Reid Adams, second by Mr. Stinnett that Council Bill No. 2018-158 be approved on an emergency basis. Mr. Stanley complimented the Joplin High School football team and all those that supported them in their endeavors this season.

Mrs. Reid Adams stated she had a citizen complaint regarding a used syringe with a needle that was found in the men's restroom at the Senior Citizen Center. She said the seniors are asking that disposal boxes be installed in the restrooms, at a cost of about \$75 each.

Mayor Shaw asked if the City Manager to look into the drop-off spot at the senior center. Mr. Anselm stated he will look into and get back to Council.

Mr. West stated the city needs to address the traffic issue at 26th and Picher. Director Hertzberg stated a traffic study will be done.

Mr. Lawson acknowledged and thanked everyone for the expressions of sympathy at the passing of his father.

Mr. Monteleone acknowledged Assistant Public Works Director for his work as the area coordinator for the Toys for Tots program in Pittsburg KS.

Mayor Shaw encouraged everyone to attend tomorrow night's events.
