

**COUNCIL BILL NO. 2021-135**

**ORDINANCE NO**

AN ORDINANCE authorizing the City of Joplin to enter into an agreement with McClanahan Construction Co., Inc., in the amount of One Million, Two Hundred Eighty Thousand and 00/100 Dollars (\$1,280,000.00) for construction services associated with the Turkey Creek and Shoal Creek Wastewater Treatment Facilities Digester Roof Repairs project on behalf of the City of Joplin and authorizing the City Manager or his designee to execute the same by and on behalf of the City of Joplin; amending the Annual Budget of the City of Joplin for the Fiscal Year 2020-2021 as adopted by Ordinance 2020-156 on October 19, 2020; and, containing an emergency clause.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF JOPLIN, as follows:

Section 1. That the agreement by and between the City of Joplin and McClanahan Construction Co., Inc., in the amount of One Million, Two Hundred Eighty Thousand and 00/100 Dollars (\$1,280,000.00) for construction services associated with the Turkey Creek and Shoal Creek Wastewater Treatment Facilities Digester Roof Repairs project on behalf of the City of Joplin; true and accurate copy of said agreement being attached hereto and incorporated herein, be, and the same is hereby approved.

Section 2. That the City Manager of the City of Joplin, Missouri, is hereby authorized and directed to execute said agreement, or agreement in substantially similar form, by and on behalf of the City of Joplin.

Section 3. That fiscal year 2020-2021 budgeted appropriations as adopted by Ordinance 2020-156 be amended by increasing appropriations by the total amount of One Million, Two Hundred Eighty Thousand and 00/100 Dollars (\$1,280,000.00).

Section 4. That the Director of Finance is hereby directed to make all necessary entries on the City records to show the increase in appropriations.

Section 5. That upon the final approval and acceptance of the contractor's work under said contract, in substantial conformance with the attached agreement, in writing by the Director of Public Works and his certification to the effect to the Director of Finance, the contractor shall be paid from the Wastewater Treatment Fund

Section 6. That the City of Joplin hereby declares that this Ordinance, approving a construction agreement on an emergency basis due to concerns regarding staff safety (structural integrity of the existing roofs) and market volatility of materials, being an ordinance relating to a public improvement, it is an emergency within the meaning of Section 2.12(6) of the HOME RULE CHARTER of the City of Joplin, Missouri and the Council hereby declares that this ordinance shall be in full force and effect from and after its passage.
