Dr. Reid Adams introduced Council Bill No. 2021-450 - an ordinance authorizing a Participation Agreement for State Investment In Local Public Health Agencies and a Memorandum of Understanding for participation in the Children’s Health Insurance Program (CHIP) Health Services Initiatives (H.S.I.) project, by and between the State of Missouri, Department of Health and Senior Services, and the City of Joplin, Missouri, and for the City of Joplin Health Department to receive compensation, for up to One-Hundred Thousand, Sixty Dollars, no Cents, (\$100,060.00); and, authorizing the City Manager to execute the same by and on behalf of the City of Joplin, Missouri; and, containing an emergency clause.
