CALL TO ORDER

The November 8, 2021 Special Meeting of the Joplin City Council was called to order at 6:00 p.m. by Mayor Ryan Stanley.

OFFICIAL RESULTS OF THE NOVEMBER 2, 2021 SPECIAL ELECTION

The City Clerk's office received the official results of the November 2, 2021 Special Election as certified by the Jasper and Newton County Clerks and on file in the Office of the City Clerk. For the City of Joplin's Proposition Action, which would impose a local use tax, it is found and declared that the results are as follows: **Yes: 1,705 No: 1,611**

The measure needed a simple majority for passage. Proposition Action was approved by a majority of votes received and we anticipate commencing on January 1, 2022, as long as the State receives the paperwork by next Tuesday, November 16, 2021. For the record, there were 31, 958 registered voters eligible to vote in this election.
