SUMMARY

This Council Bill amends Chapter 10 Alcoholic Beverages, by repealing Section 10-3 Hours of sale generally, and enacting a new Section 10-3 Hours of sale generally in lieu thereof.

BACKGROUND

The General Assembly has historically restricted the hours of sale for alcoholic beverages for days other than Sunday to between 6:00 a.m. and 1:30 a.m. Sunday sales have been restricted to between 9:00 a.m. and 12:00 a.m. The General Assembly recently amended Section 311.293, RSMo. to make Sunday sales consistent with the other days of the week. Council Bill 2022-600 and Council Bill 2022-601 amend the City Code to mirror state statute.

COUNCIL BILL NO. 2022-600

ORDINANCE NO.

AN ORDINANCE amending Chapter 10 Alcoholic Beverages, by repealing Section 10-3 Hours of sale generally, and enacting a new Section 10-3 Hours of sale generally in lieu thereof.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF JOPLIN, MISSOURI, as follows:

Section 1. That Chapter 10 Alcoholic Beverages, Section 10-3 Hours of sale generally is repealed, and a new Section 10-3 Hours of sale generally is enacted in lieu thereof, as follows:

“Sec. 10-3 Hours of sale generally.

No person having a license under this chapter, and no employee of such person, shall sell, give away or allow the consumption of or otherwise dispose of any intoxicating liquor in any quantity, or suffer the such acts to be done upon or about his premises, between the hours of 1:30 a.m. and 6:00 a.m.”
