

**JOPLIN CITY COUNCIL
SPECIAL MEETING MINUTES
MONDAY, JANUARY 10, 2022**

CALL TO ORDER

Mayor Ryan Stanley called the January 10, 2022 Joplin City Council special meeting to order at 5:45p.m.

City Clerk Holly Nagy read the Special Call:

Notice is hereby given that the City Council of the City of Joplin, Missouri, will conduct a Special Meeting at 5:45 p.m. on Monday, January 10, 2022, at Joplin City Hall, 5th Floor Council Chambers, 602 S. Main Street for the purpose of an emergency ordinance for the Emergency Enterprise Railroad Crossing Sewer Repair. The City Council will adjourn to a Work Session after the Special Meeting.

Mr. Cortez seconded the motion. Voting in favor were Council Members: Copple, Cortez, Lawson, Reid Adams, Shaw, Stanley, Stinnett, and Williams, 8. Nays: 0. Absent: 1, Monteleone.

ORDINANCES- EMERGENCY:

Mr. Stinnett introduced Council Bill No. 2022-103- an ordinance authorizing the City of Joplin to enter into an agreement with Goins Enterprises, Inc., in the amount of One Hundred Ninety-five Thousand, Four Hundred Nine and 00/100 Dollars (\$195,409.00) for the Emergency Enterprise Railroad Crossing Sewer Repair; authorizing the City Manager or his designee to execute the same by and on behalf of the City of Joplin; and containing an emergency clause. Motion by Mr. Stinnett, second by Mr. Lawson that Council Bill No. 2022-103 be approved on an emergency basis. Voting in favor were Council Members: Copple, Cortez, Lawson, Reid Adams, Shaw, Stanley, Stinnett, and Williams, 8. Nays: 0. Absent: 1, Monteleone. The Council Bill was declared adopted and entitled **Ordinance No. 2022-005.**

Adjourn to Work Session- Mr. Copple made a motion to adjourn the meeting into the work session. Second by Mr. Cortez. Voting in favor were Council Members: Copple, Cortez, Lawson, Reid Adams, Shaw, Stanley, Stinnett, and Williams, 8. Nays: 0. Absent: 1, Monteleone. Meeting adjourned at 5:55 PM.
