

**COUNCIL BILL NO. 2022-156**

**ORDINANCE NO**

AN ORDINANCE authorizing the City of Joplin to enter into an construction agreement with Goins Construction Company Inc., in the amount of Four Hundred Fifty-Four Thousand Two Hundred and No/100 Dollars (\$454,200.00) for construction services associated with the Turkey Creek WWTF Rehabilitation project concerning the Oxidation Ditch rotor replacements on behalf of the City of Joplin and authorizing the City Manager or his designee to execute the same by and on behalf of the City of Joplin; and, containing an emergency clause.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF JOPLIN, as follows:

Section 1. That the construction agreement by and between the City of Joplin and Goins Construction Inc., in the amount of Four Hundred Fifty-Four Thousand Two Hundred and No/100 Dollars (\$454,200.00) for construction services associated with the Turkey Creek WWTF Rehabilitation project concerning the Oxidation Ditch rotor replacements on behalf of the City of Joplin; true and accurate copy of said agreement being attached hereto and incorporated herein, be, and the same is hereby approved.

Section 2. That the City Manager of the City of Joplin, Missouri, is hereby authorized and directed to execute said agreement, or agreement in substantially similar form, by and on behalf of the City of Joplin.

Section 3. That upon final approval and acceptance of Goins Construction’s work under said contract, in substantial conformance with the attached work authorization, in writing to the Director of Public Works and his certification to the effect to the Director of Finance, Goins Construction Company Inc., shall be paid from the Sanitary Sewer Fund.

Section 4. That the City of Joplin hereby declares that this Ordinance, approving a construction agreement on an Emergency basis due to public health concerns associated with sanitary sewer overflows, and equipment replacement, being an ordinance relating to a public improvement, it is an emergency within the meaning of Section 2.12(6) of the HOME RULE CHARTER of the City of Joplin, Missouri and the Council hereby declares that this ordinance shall be in full force and effect from and after its passage.
