2. Purchases between \$1,000 and \$15,000 require written bids

1. Describe the non-for-profit applying for grant funds.
Ozark Center is the area's largest and most comprehensive behavioral healthcare provider. Our staff provides effective, caring and confidential services for adults, families and children, including: individual, group and family counseling and therapy, Psychiatric services/medication management, Residential Care, 24-hour crisis services, and In-home support. Ozark also provides housing options for individuals diagnosed with a mental illness that require additional supportive services. It is our goal to assist people of all ages who are dealing with mental illness, addiction, trauma and/or abuse to develop the skills essential for living a life with dignity and purpose. Since opening, we have continued to expand services and programs in the communities we serve through innovation, pursuit of grants, fundraising activities. Ozark Center serves over 15,000 individuals per year and provides services regardless of ability to pay. Over 65% of the individuals we serve have Medicaid, are underinsured or uninsured.
2. Describe the public service selected on the project type selected on the previous page.
Ozark Center provides transportation services (Project Type: 05E Transportation Services) to individuals in our residential, housing units, and day treatment programs who do not have other means of transportation available to get to their medical and/or behavioral health appointments. Ensuring access to care and treatment in a timely manner is vital to maintaining their physical and mental health. Most of the individual would not be able to attend their appointments without these vital transportation services being available. Ozark Center offers these transportation services free of charge to consumers in these intensive programs.
3. Describe the Limited Clientele population in accordance with 24 CFR 570.208(a)(2) for which service is provided. (Alternatively, the program must require income documentation for eligibility.)
The transportation services provided by Ozark Center benefit children and adults who are in the low to moderate income level. Most of the individuals served in the transportation program qualify for Missouri Medicaid or are unemployed.
Transportation services are available to clients of the following:
 - a. Pre-Adult Transitional Housing (PATH) provides housing and treatment services to youth age 17-25 who have aged out of the foster system or otherwise find themselves homeless and also have been diagnosed with a mental illness. PATH provides services to help build the skills needed to manage their mental health illness, gain employment, and/ or continue their education.
 - b. HUD Housing Apartments that offer a bridge between group homes and independent living that allow occupants to move toward self-care by attending day treatment and outpatient treatment services.
 - c. Residential Care Facility for adults with persistent of chronic mental illness, offers 24/7 direct care.

- d. Turnaround Ranch that provides 24-hour care for youths experiencing emotional and behavioral problems such as trauma, depression, substance abuse, and family problems.
- e. Variety of mental health programs such as, but not limited to adult community services, substance use services, and services for veterans.
- f. Mental Health Court is a 12-18 month program to help individuals manage their mental health illness; thereby providing them with the skills need to achieve a productive, criminal-free life. Many homeless people end up breaking the law and serving time in jail because of an undiagnosed and untreated mental illness. Over 9,000 people are incarcerated annually in Joplin and approximately 40% have mental health issues. The goal is to reduce homeless population and improve public safety by providing care to those with mental illness.

4. How will the grant funds be used to improve services.

The grant funds will be used to purchase an additional passenger vehicle. This will allow our vehicle fleet to provide safe, reliable transportation services to individuals in need of physical and behavioral health services. Several of our vehicles are showing their age and/or need expensive repairs. The addition of a new vehicle would allow us to put the new vehicles into the rotation and allow us to use the existing vehicles in place as backups for times our other vehicles are in the repair shop, obtaining preventive maintenance, or otherwise not in operation. Having a few backup vehicles will ensure transportation is always available to those in need of this service. Ozark Center provides transportation services to more than 60 individuals and multiple trips per day. Having vehicles to transport clients and providing adequate space in the vehicles so that they are comfortable and can maintain a safe distance from other passengers is very important to us.

5. How will the use of grant funds be used to respond to the Covid-19 pandemic.

Purchase of the larger passenger vehicles will ensure our clients have access to timely physical and behavioral health services. The size of the vehicles requested will provide ample space so the individuals we are transporting can spread out in the vehicle, thereby helping prevent the spread of COVID-19. By purchasing a larger vehicle, it will free up our smaller ones to transport those individuals that have tested positive or have been exposed without spreading the virus to numerous others.

Ozark Center is requesting to purchase the 2019 Ford Transit for \$42,988. This vehicle is high top, meaning they are taller inside which would help our elderly clients and those with disabilities. A detailed description of the vehicle is attached.
