

COUNCIL BILL NO. 2023-137

ORDINANCE NO.

AN ORDINANCE authorizing the acceptance of an agreement by and between the City of Joplin and Satterlee Plumbing, Heating and Air Conditioning Company in the amount of Four Hundred Twenty-Eight Thousand One Hundred and Five and 00/100 Dollars (\$428,105.00) for Construction & Installation services for the replacement of the Justice Center Modular Chiller; authorizing the City Manager or his designee to execute the same by and on behalf of the City of Joplin; amending the Annual Budget of the City of Joplin for the Fiscal Year 2022-2023 as adopted by Ordinance 2022-161 on October 17, 2022; and, containing an emergency clause.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF JOPLIN, MISSOURI, as follows:

Section 1. That the agreement by and between the City of Joplin and Satterlee Plumbing, Heating and Air Conditioning Company for Construction & Installation services in the amount of Four Hundred Twenty-Eight Thousand One Hundred and Five and 00/100 Dollars (\$428,105.00) for the replacement of the Justice Center Modular Chiller; a true and accurate copy of said agreement being attached hereto and incorporated herein as Exhibit "A", is hereby approved.

Section 2. That the City Manager of the City of Joplin, Missouri, or his designee, is hereby authorized and directed to execute said agreement, or agreement in substantially similar form, by and on behalf of the City of Joplin, Missouri.

Section 3. That fiscal year 2022-2023 budgeted appropriations as adopted by Ordinance 2022-161 be amended by increasing revenue by the total amount of Four Hundred Twenty-Eight Thousand One Hundred and Five and 00/100 Dollars (\$428,105.00) and by increasing appropriations by the total amount of Four Hundred Twenty-Eight Thousand One Hundred and Five and 00/100 Dollars (\$428,105.00)

Section 4. That the Director of Finance is hereby directed to make all necessary entries on the City records to show the increase in revenue and appropriations.

Section 5. That the City of Joplin declares that this ordinance relating to public improvement is an emergency within the meaning of Section 2.12(6) of the HOME RULE CHARTER of the City of Joplin, Missouri and the Council hereby declares that this ordinance shall be in full force and effect from and after passage. Specifically, this council bill needs to be approved due to price volatility in the current manufacturing market.
