CALL TO ORDER

The January 3, 2023, regular meeting of the Joplin City Council was called to order at 6:00 p.m. by Mayor Doug Lawson.

News from the Public Information Office

If citizens want to know more about the Joplin Police Department, they have a great opportunity by enrolling in upcoming Citizens Police Academy. Offered as a 14-week program, the Academy is FREE of charge and provides an interactive, behind-the-scenes program taught by police officers.

The classes are every Thursday evening starting February 2nd from 6 to 9 p.m. The Citizens Academy ends on May 4th with a closing ceremony and dinner. The class size is limited to 25 participants. Applicants must be 21 years or older and pass a background check. If interested, citizens can contact the Police Department or go to the Police Department's website at joplinpolice.org.

We have an opportunity that citizens will want to participate. We just issued a survey where citizens can provide their input about City services and operations on how we are utilizing currently available resources.

This survey gives Joplin residents the chance to provide meaningful feedback across all departments and divisions and helps direct budget resources and planning efforts. We have all heard different comments on various services, so this is a good opportunity for the public to share their thoughts. All responses are anonymous and will be tabulated to share. The survey is open from January 3 to January 20, 2023. Printed copies of the survey can also be completed at the Joplin Public Library, 1901 East 20th Street in Joplin. Please share your thoughts!

The City of Joplin is well-positioned to improve community-wide broadband access and we need the help of our residents and businesses! We are requesting all citizens of Joplin to log data about their internet and speed connectivity through a Federal Communications Commission (FCC) study.

This will help update the broadband internet maps and provide critical data to the Missouri Department of Economic Development which directs resources to build out future internet infrastructure.

To complete this request, they will log onto the Missouri Dept. of Economic Development page at <https://ded2.mo.gov/connecting-all-missourians> and click on the map portal listed on this page to see how their home or business is currently shown with regard to internet connectivity and speed. If something is incorrect, they should bring it to the attention of government officials by following the challenge process laid out on the map.

This input will help identify and capture gaps in service and coverage.

As some may be aware of, the City is currently soliciting proposals from broadband internet providers to increase and expand Joplin residential and business connectivity and speeds. As part of this process, we are encouraging everyone to submit their connectivity information to the State of Missouri by going to the FCC map portal.

And for those taking their Christmas trees down and not sure how to dispose of them – the City offers three locations that residents can drop them off free of charge. Locations include:

- Humphrey Park on Utica Street in the Royal Heights area;
- McIndoe Park at Glendale Road and Jackson Avenue – place trees in southwest corner of parking lot; and
- Public Works Center at 1301 West 2nd Street.

Citizens should ensure that their tree is completely stripped of all decorations, and place it near the "Christmas Tree Drop-Off" sign posted at one of these locations. The sites are open through January 31.

UNFINISHED BUSINESS**NEW BUSINESS****CASE NO. 068-22**


