News from the Public Information Office

Joplin Parks and Recreation has partnered with Missouri Southern State University again this year to host Joplin's Independence Day Celebration tomorrow, July 4 at Fred G. Hughes Stadium on Missouri Southern's campus.

This family event will feature live music by The Mixtapes, food trucks, and fireworks. The Schedule includes

- 5:30pm: Event Kick Off: Food Trucks Open
- 7:00pm: Stadium Opens to Visitors
- 7:30pm: Live Music by The Mixtapes
- 9:45pm: Fireworks Show (approximate show time is 20 minutes)

The fireworks show will be set to music, and spectators can tune in at 88.7 KXMS, to enjoy this. Guests are welcome to sit on the west side of the stadium, or they may bring lawn chairs and/or blankets for lounging in the grassy area on the west side of the field.

The stadium's north end zone and east side will be closed to the public for safety purposes. There is no fee for admission to this family fun event; all ages are welcome.

As Independence Day, July 4, approaches, citizens should keep safety in mind as they handle fireworks to avoid any problems. Important dates to remember:

- Fireworks may only be sold within the Joplin City limits through July 4th.
- They may be discharged from 12 Noon to 11 p.m., July 1 through the 4th.

The City also encourages residents to clean up their shoot sites to eliminate debris and trash in the city. Fireworks should be cooled before they are disposed of. To help ensure items are extinguished, remaining fireworks barrels can be sprayed with water or dunked in a bucket before disposing of them.


