News from the Public Information Office

It's that time again – Back to School – for students of all ages.

It's never more important for drivers to slow down and pay attention than when kids are present – especially before and after school. Drivers, please use caution. Watch for children at school bus stops. Be alert; children often are unpredictable.

Obey reduced speed limits in school zones. Prepare to stop for pedestrians in and near the crosswalks.

If driving behind a bus, allow a greater following distance than if you were driving behind a car. This will allow more time to stop once the yellow lights start flashing. And please remember: it is illegal to pass a school bus that is stopped to load or unload children.

With schools back in session, there will be more cars on the roads along with school buses stopping frequently. This could cause some delays, so plan a little extra time and don't rush so you and everyone on the road can arrive to school, work and other destinations safely.

The City is looking for School Crossing Guards who work with the Joplin Police Department to help students cross the street safely at designated crosswalks. This part-time position works one hour in the morning and one hour in the afternoon Monday through Friday. If interested, people can apply at JoplinMo.org/jobs or in the Human Resources here at City Hall Monday through Friday 8 a.m. to 5 p.m.

Mark your calendar for September 8 and 9 for ***ROCK STOCK: Joplin Local Legends Concert Weekend***. This is the final event of the Joplin 150th Celebration and will reunite local bandmates who may no longer formally play together but whose past performances have left lasting memories for many in our community.

Friday night will focus more on the music of the 90s to today, and Saturday night will reflect on those from the 70s and 80s. The event will be held at the Amphitheater in Landreth Park.

Mr. Cortez introduced Council Bill No. 2023-135 - AN ORDINANCE authorizing the approval of the 2023 Public Transportation Agency Safety Plan (PTASP) Safety Targets for the City of Joplin, MO, Metro Area Public Transit System (MAPS) and Sunshine Lamp Trolley. Approval of the annual PTASP Safety Targets are required by the Federal Transit Administration (FTA) regulations set in 49 CFR Part 673 of the Federal guidelines. Motion by Mr. Cortez, second by Dr. Farnham that Council Bill No. 2023-135 be passed on the first reading and advance to second and third. Voting in favor were Council Members: Copple, Cortez, DeTar, Farnham, Lawson, Shaw, Spencer, Stinnett, and Williams, 9. Nays: 0. The Bill was read as Council Bill No. 2023-135.

COUNCIL BILL NO. 2023-147

Mr. DeTar introduced Council Bill No. 2023-147 - AN ORDINANCE amending Chapter 114, Traffic, Article IX, Pedestrians. Motion by Mr. DeTar, second by Ms. Spencer that Council Bill No. 2023-147 be passed on the first reading and advance to second and third. Voting in favor were Council Members: Copple, Cortez, DeTar, Farnham, Lawson, Shaw, Spencer, Stinnett, and Williams, 9. Nays: 0. The Bill was read as Council Bill No. 2023-147.

Declare Excess Surplus Property for The Annual City of Joplin Auction on September 16, 2023.

Motion by Mr. DeTar, second by Mr. Cortez to approve excess surplus property. Voting in favor were Council Members: Copple, Cortez, DeTar, Farnham, Lawson, Shaw, Spencer, Stinnett, and Williams, 9. Nays: 0.

Mr. DeTar would like for the City Manager to direct staff to bring back numbers on the cost of replacing trees on Main Street and to replace banners on light posts.


Mr. Copple would like to know how the Tree City USA and MDC grant money was spent and what projects were completed.

Vote to go into closed session, which shall pertain to leasing, purchasing or sale of real estate by a public governmental body where public knowledge of the transaction might adversely affect the legal consideration therefore; and which shall pertain to the hiring, firing, disciplining, or promotion of an employee or particular employees of a governmental body involving personal information as set forth in Section 610.021(2)(3) RS Mo, as amended, 2020. This meeting, record, and vote to be closed to the extent provided by law. The City Council shall adjourn at the end of the session.
